# Boundary element methods for parabolic boundary control problems

#### Abstract

In this paper we analyse constrained optimal Dirichlet boundary control problems subject to the linear heat equation. We propose to use boundary integral equations to solve the coupled optimality system, and we present results on unique solvability and related a priori error estimates for a symmetric Galerkin boundary element method. A numerical example confirms the analytical results.


## 1 Introduction

Optimal control problems subject to elliptic or parabolic partial differential equations are of great interest, both from a mathematical and an application point of view, see, e.g., $[4,7,15]$. In most cases, the numerical solution by using finite elements is based on the variational formulation of the optimality system. In particular when considering boundary control problems, boundary integral formulations and boundary element methods may be an interesting alternative to finite element methods. In [10] we have introduced and analysed a symmetric Galerkin boundary element method for the solution of Dirichlet boundary control problems subject to the Poisson equation. When describing the solutions of both the primal and adjoint value problems by using boundary integral equations, a variational inequality in the Sobolev trace space $H^{1 / 2}(\Gamma)$ has to be solved, see also [14]. Since the state enters the adjoint problem as a volume density, an appropriate reformulation of the related Newton potentials by using Bi-Laplace boundary integral operators has to be introduced.

In this paper we analyse the Dirichlet boundary optimal control problem governed by the linear heat equation as a model problem. Several variational formulations for a Dirichlet control in $L_{2}(\Gamma)$ are considered in [6], and a Galerkin finite element method for the numerical solution of a parabolic Neumann control problem was proposed in [16], where a backward discretization in time was used. Instead, here we propose and analyse the use of boundary element methods to solve the related optimality system, see also [11].

Boundary integral formulations for the heat equation are well established, see, e.g., $[2,3,9]$. In fact, the state $u$ and the adjoint state $p$ can be represented by some layer heat potentials. Since the final state $u$ enters the adjoint heat equation, which is in fact reverse in time, we need to modify the presentation of the related Newton potential by using an auxiliary function which is related to the fundamental solution of the heat equation. With this, similar formulations of boundary integral equations as in the case of stationary boundary control problems [10] are obtained.

This paper is organised as follows. In Sect. 2 we describe the model problem where the Dirichlet control is considered in the boundary energy space $H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$, where $\Sigma:=\Gamma \times(0, T)$ is the boundary of the space time cylinder, and where an equivalent norm is induced by the hypersingular layer heat potential $D$, see, e.g., [3]. Moreover, we discuss the optimality system, which consists of the primal problem, the adjoint problem, and the optimality condition. In Sect. 3 we first recall the boundary integral equation approach in the case of the heat equation which can be used to describe the primal state $u$, and the adjoint state $p$. Since the final state $u(T)$ enters the adjoint equation as a final termination condition, we introduce an auxiliary function to rewrite the related volume potential by using surface potentials only. It turns out that we can state almost the same mapping properties of the resulting boundary integral operators as in the elliptic case [10]. The symmetric Galerkin boundary element approximation of the resulting variational inequality is formulated and analysed in Sect. 4. Finally, in Sect. 5, a numerical example is given which confirms the theorical results.

## 2 Parabolic Dirichlet boundary control problems

For a bounded Lipschitz domain $\Omega \subset \mathbb{R}^{d}, d=2,3$, with boundary $\Gamma=\partial \Omega$ and for a fixed real number $T>0$, we define the time interval $I:=(0, T)$, the space time cylinder $Q:=\Omega \times I$, and its boundary $\Sigma:=\Gamma \times I$. We consider the model problem to find a Dirichlet control $z$ to minimize the distance of the final temperature $u(\cdot, T)$ from a desired temperature $\bar{u}$, i.e. we consider the cost functional

J(u, z)=\frac{1}{2} \int_{\Omega}[u(x, T)-\bar{u}(x)]^{2} d x+\frac{\alpha}{2}\langle D z, z\rangle_{\Sigma} \tag{2.1}
\end{equation*}
$$

to be minimized subject to the heat equation

$$
\begin{align*}
\partial_{t} u(x, t)-\Delta u(x, t) & =0 & & \text { for }(x, t) \in Q, \\
u(x, t) & =z(x, t) & & \text { for }(x, t) \in \Sigma,  \tag{2.2}\\
u(x, 0) & =u_{0}(x) & & \text { for } x \in \Omega,
\end{align*}
$$

and subject to pointwise control constraints

$$
\begin{equation*}
z \in \mathcal{U}_{\mathrm{ad}}:=\left\{w \in H^{\frac{1}{2}, \frac{1}{4}}(\Sigma): z_{1}(x, t) \leq w(x, t) \leq z_{2}(x, t) \text { for }(x, t) \in \Sigma\right\} \tag{2.3}
\end{equation*}
$$

For the definition of the used Sobolev spaces, see, e.g., [1, 3]. We assume $\bar{u}, u_{0} \in L_{2}(\Omega)$, $\alpha \in \mathbb{R}_{+}, z_{1}, z_{2} \in H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$, and $D: H^{\frac{1}{2}, \frac{1}{4}}(\Sigma) \rightarrow H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)$ is the hypersingular heat boundary integral operator [3] which defines an equivalent norm in $H^{\frac{1}{2}}, \frac{1}{4}(\Sigma)$. In particular, for $z \in H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$ we have

(D z)(x, t):=-\frac{\partial}{\partial n_{x}} \int_{0}^{t} \int_{\Gamma} \frac{\partial}{\partial n_{y}} \mathcal{E}(x-y, t-\tau) z(y, \tau) d s_{y} d \tau \quad \text { for }(x, t) \in \Sigma
$$

where

$$
\mathcal{E}(x, t)=\left\{\begin{array}{cc}
\frac{1}{(4 \pi t)^{d / 2}} e^{-|x|^{2} / 4 t} & \text { for } t>0  \tag{2.4}\\
0 & \text { for } t \leq 0
\end{array}\right.
$$

is the fundamental solution of the heat equation. Let $v$ be a given function defined on $\Omega \times \mathbb{R}_{+}\left(\right.$or $\left.\Gamma \times \mathbb{R}_{+}\right)$, and let $t_{0} \in \mathbb{R}_{+}$be arbitrary. Then we define the time reversal map $\kappa_{t_{0}}$ by

The hypersingular heat boundary integral operator $D$ is $H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$-elliptic and self-adjoint with respect to a time-twisted duality, see [3], i.e.,

\langle D z, z\rangle_{\Sigma} \geq c_{1}^{D}\|z\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}}^{2}, \quad\left\langle D z, \kappa_{T} w\right\rangle_{\Sigma}=\left\langle D w, \kappa_{T} z\right\rangle_{\Sigma} \quad \text { for all } z, w \in H^{\frac{1}{2}, \frac{1}{4}}(\Sigma) \tag{2.6}
\end{equation*}
$$

As in $[4,7]$ we obtain the related optimality conditions as follows:
Theorem 2.1 Let $(u, z) \in H^{1, \frac{1}{2}}(Q) \times H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$ be an optimal solution of the optimal control problem (2.1)-(2.3). Then there exists a unique $p \in H^{1, \frac{1}{2}}(Q)$ satisfying the adjoint heat equation

p(x, t) & =0 & & \text { for }(x, t) \in \Sigma,  \tag{2.7}\\
p(x, T) & =u(x, T)-\bar{u}(x) & & \text { for } x \in \Omega,
\end{align*}
$$

and the optimality condition

$$
\begin{equation*}
\left\langle\alpha \widetilde{D} z-\partial_{n} p, w-z\right\rangle_{\Sigma} \geq 0 \quad \text { for all } w \in \mathcal{U}_{a d} \tag{2.8}
\end{equation*}
$$

where

$$
\begin{equation*}
\widetilde{D}:=\frac{1}{2}\left(D+\kappa_{T} D \kappa_{T}\right) . \tag{2.9}
\end{equation*}
$$

Proof. For a given $z \in H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$ there exists a unique solution $u_{z} \in H^{1, \frac{1}{2}}(Q)$ of the primal heat equation (2.2), see, e.g., [3]. Then the cost functional (2.1) can be rewritten in a reduced form as

\widetilde{J}(z)=\frac{1}{2}\left\|u_{z}(T)-\bar{u}\right\|_{L_{2}(\Omega)}^{2}+\frac{\alpha}{2}\langle D z, z\rangle_{\Sigma} .
$$

Let $h \in H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$ be an arbitrary but given direction for which we have

& \quad=\frac{1}{2}\left\|u_{z+h}(T)-\bar{u}\right\|_{L_{2}(\Omega)}^{2}-\frac{1}{2}\left\|u_{z}(T)-\bar{u}\right\|_{L_{2}(\Omega)}^{2}+\frac{\alpha}{2}\langle D(z+h), z+h\rangle_{\Sigma}-\frac{\alpha}{2}\langle D z, z\rangle_{\Sigma} \\
& \quad=\left\langle u_{z}(T)-\bar{u}, v(T)\right\rangle_{L_{2}(\Omega)}+\frac{1}{2}\|v(T)\|_{L_{2}(\Omega)}^{2}+\frac{\alpha}{2}\langle D z, h\rangle_{\Sigma}+\frac{\alpha}{2}\langle D h, z\rangle_{\Sigma}+\frac{\alpha}{2}\langle D h, h\rangle_{\Sigma},
\end{aligned}
$$

and where $v(x, t):=u_{z+h}(x, t)-u_{z}(x, t)$ is the unique solution of the heat equation

\partial_{t} v(x, t)-\Delta v(x, t)=0 \quad \text { in } Q, \quad v(x, t)=h(x, t) \quad \text { on } \Sigma, \quad v(x, 0)=0 \quad \text { on } \Omega .
$$

By applying Green's second formula for the pair $(v, p)$,

& \int_{0}^{T} \int_{\Omega}\left[p(x, t)\left(\partial_{t}-\Delta\right) v(x, t)+v(x, t)\left(\partial_{t}+\Delta\right) p(x, t)\right] d x d t \\
& =\int_{\Omega}[v(x, T) p(x, T)-v(x, 0) p(x, 0)] d x \\
& \quad+\int_{0}^{T} \int_{\Gamma}\left(\frac{\partial}{\partial n_{x}} p(x, t) v(x, t)-\frac{\partial}{\partial n_{x}} v(x, t) p(x, t)\right) d s_{x} d t
\end{aligned}
$$

we obtain

$$
\int_{\Omega}\left[u_{z}(x, T)-\bar{u}(x)\right] v(x, T) d x+\int_{\Gamma} \frac{\partial}{\partial n_{x}} p(x, t) h(x, t) d s_{x} d t=0 .
$$

Therefore, by using the self-adjointness (2.6) of the hypersingular heat boundary integral operator $D$ we conclude

\begin{aligned}
& \widetilde{J}(z+h)-\widetilde{J}(z) \\
& \quad=\frac{\alpha}{2}\langle D z, h\rangle_{\Sigma}+\frac{\alpha}{2}\left\langle\kappa_{T} D \kappa_{T} z, h\right\rangle_{\Sigma}-\left\langle\partial_{n} p, h\right\rangle_{\Sigma}+\frac{1}{2}\|v(T)\|_{L_{2}(\Omega)}^{2}+\frac{\alpha}{2}\langle D h, h\rangle_{\Sigma} \\
& \quad=\left\langle\alpha \widetilde{D} z-\partial_{n} p, h\right\rangle_{\Sigma}+\mathcal{O}\left(\|h\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}}^{2}\right)
\end{aligned}
$$

where we have used

$$
\|v(T)\|_{L_{2}(\Omega)} \leq c\|h\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}}, \quad\langle D h, h\rangle_{\Sigma} \leq c_{2}^{D}\|h\|_{H^{\frac{1}{2}}, \frac{1}{4}(\Sigma)}^{2} .
$$

This implies that the gradient of $\widetilde{J}(z)$ satisfies

\langle\nabla \widetilde{J}(z), h\rangle_{\Sigma}=\left\langle\alpha \widetilde{D} z-\partial_{n} p, h\right\rangle_{\Sigma}
$$

from which the assertion follows, see also $[4,7]$.

In the following we will use a boundary element approach to solve the optimality system, i.e. the primal heat equation (2.2), the adjoint heat equation (2.7), and the optimality condition (2.8).

## 3 Boundary integral equations

In this section we first recall the boundary integral equations for the heat equation (2.2). Some mapping properties of the standard boundary integral layer heat operators can be found in, e.g., [3]. For the adjoint heat equation (2.7), instead of using the volume potential of the state $u$, we introduce some boundary potentials with a regular kernel.

### 3.1 The primal heat equation

Let us first consider the primal heat equation (2.2), where the solution is given by the representation formula for $(\widetilde{x}, t) \in Q$,

u(\widetilde{x}, t)= & \int_{0}^{t} \int_{\Gamma} \mathcal{E}(\widetilde{x}-y, t-\tau) \frac{\partial}{\partial n_{y}} u(y, \tau) d s_{y} d \tau \\
& -\int_{0}^{t} \int_{\Gamma} \frac{\partial}{\partial n_{y}} \mathcal{E}(\widetilde{x}-y, t-\tau) z(y, \tau) d s_{y} d \tau+\int_{\Omega} \mathcal{E}(\widetilde{x}-y, t) u_{0}(y) d y
\end{aligned}
$$

where $\mathcal{E}(x, t)$ is the fundamental solution of the heat equation as given in (2.4). By taking the limit $\Omega \ni \widetilde{x} \rightarrow x \in \Gamma$, we obtain the first kind boundary integral equation to find $\omega(x, t):=\partial_{n} u(x, t)$ such that

(V \omega)(x, t)=\left(\frac{1}{2} I+K\right) z(x, t)-\left(M_{0} u_{0}\right)(x, t) \quad \text { for }(x, t) \in \Sigma \tag{3.1}
\end{equation*}
$$

Here,

(V \omega)(x, t)=\int_{0}^{t} \int_{\Gamma} \mathcal{E}(x-y, t-\tau) \omega(y, \tau) d s_{y} d \tau \quad \text { for }(x, t) \in \Sigma
$$

is the single layer heat boundary integral operator $V: H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma) \rightarrow H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$, and

$$
(K z)(x, t)=\int_{0}^{t} \int_{\Gamma} \frac{\partial}{\partial n_{y}} \mathcal{E}(x-y, t-\tau) z(y, \tau) d s_{y} d \tau \quad \text { for }(x, t) \in \Sigma
$$

is the double layer heat boundary integral operator $K: H^{\frac{1}{2}, \frac{1}{4}}(\Sigma) \rightarrow H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$, see $[3]$. Moreover,

\left(M_{0} u_{0}\right)(x, t)=\int_{\Omega} \mathcal{E}(x-y, t) u_{0}(y) d y \quad \text { for }(x, t) \in \Sigma
$$

is the related Newton potential. Since the single layer heat boundary integral operator $V$ is $H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)$-elliptic, i.e.,

\langle V \omega, \omega\rangle_{\Sigma} \geq c_{1}^{V}\|\omega\|_{H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)}^{2} \quad \text { for all } \omega \in H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)
$$

the boundary integral equation (3.1) is solvable, when a Dirichlet datum $z$ is given, and we obtain

\omega=V^{-1}\left(\frac{1}{2} I+K\right) z-V^{-1} M_{0} u_{0} \tag{3.2}
\end{equation*}
$$

### 3.2 The adjoint heat equation

Next we consider the adjoint heat equation (2.7). Since the time reversal of the adjoint state variable, $\kappa_{T} p$, is a solution of the heat equation, i.e.,

\partial_{t}\left(\kappa_{T} p\right)(x, t)-\Delta\left(\kappa_{T} p\right)(x, t) & =0 & & \text { for }(x, t) \in Q, \\
\kappa_{T} p(x, t) & =0 & & \text { for }(x, t) \in \Sigma, \\
\kappa_{T} p(x, 0) & =u(x, T)-\bar{u}(x) & & \text { for } x \in \Omega,
\end{aligned}
$$

the representation formula for $(\widetilde{x}, t) \in Q$ gives

$$
\begin{equation*}
\kappa_{T} p(\widetilde{x}, t)=\int_{0}^{t} \int_{\Gamma} \mathcal{E}(\widetilde{x}-y, t-\tau) \frac{\partial}{\partial n_{y}} \kappa_{T} p(y, \tau) d s_{y} d \tau+\int_{\Omega} \mathcal{E}(\widetilde{x}-y, t) \kappa_{T} p(y, 0) d y \tag{3.3}
\end{equation*}
$$

and therefore the first kind boundary integral equation

$$
\begin{equation*}
\left(V\left(\kappa_{T} q\right)\right)(x, t)=\left(M_{0} \bar{u}\right)(x, t)-\left(M_{0} u(\cdot, T)\right)(x, t) \quad \text { for }(x, t) \in \Sigma \tag{3.4}
\end{equation*}
$$

to determine the unknown Neumann datum $q(x, t)=\partial_{n} p(x, t)$ for $(x, t) \in \Sigma$ follows.
In (3.4), the unknown state $u(\cdot, T)$ at the final time $T$ appears in the Newton potential. Hence, in what follows we will modify the representation formula (3.3). The crucial idea is to use an auxiliary function

\begin{equation*}
G(x, t, \tau)=\left(\frac{t}{T+t-\tau}\right)^{d / 2} e^{\frac{T-\tau}{T+t-\tau} \frac{|x|^{2}}{4 t}} \quad \text { for } x \in \Omega ; t, \tau \in(0, T) \tag{3.5}
\end{equation*}
$$

which satisfies

\mathcal{E}(x, t) G(x, t, \tau)=\mathcal{E}(x, T+t-\tau), \quad \lim _{\tau \rightarrow T^{-}} G(\widetilde{x}-y, t, \tau)=1 \quad \text { for all } t \in(0, T)
$$

For $y \in \Omega$ we then have

& u(y, T)=u(y, T) G(\widetilde{x}-y, t, T)-u(y, 0) G(\widetilde{x}-y, t, 0)+u_{0}(y) G(\widetilde{x}-y, t, 0) \\
& \quad=\int_{0}^{T} \partial_{\tau}[u(y, \tau) G(\widetilde{x}-y, t, \tau)] d \tau+u_{0}(y) G(\widetilde{x}-y, t, 0) \\
& \quad=\int_{0}^{T} \partial_{\tau} G(\widetilde{x}-y, t, \tau) u(y, \tau) d \tau+\int_{0}^{T} G(\widetilde{x}-y, t, \tau) \partial_{\tau} u(y, \tau) d \tau+u_{0}(y) G(\widetilde{x}-y, t, 0) .
\end{aligned}
$$

Hence we can write the Newton potential in the representation formula (3.3) as

\left(M_{0} u(\cdot, T)\right)(\widetilde{x}, t)= & \int_{\Omega} \mathcal{E}(\widetilde{x}-y, t) u(y, T) d y \\
= & \int_{0}^{T} \int_{\Omega} \mathcal{E}(\widetilde{x}-y, t) \partial_{\tau} G(\widetilde{x}-y, t, \tau) u(y, \tau) d y d \tau \\
& \quad+\int_{0}^{T} \int_{\Omega} \mathcal{E}(\widetilde{x}-y, t) G(\widetilde{x}-y, t, \tau) \Delta_{y} u(y, \tau) d y d \tau \\
& \quad+\int_{\Omega} \mathcal{E}(\widetilde{x}-y, t) G(\widetilde{x}-y, t, 0) u_{0}(y) d y
\end{aligned}
$$

It is easy to check that

\Delta_{y}[\mathcal{E}(\widetilde{x}-y, t) G(\widetilde{x}-y, t, \tau)]=\Delta_{y} \mathcal{E}(\widetilde{x}-y, T+t-\tau)=-\mathcal{E}(\widetilde{x}-y, t) \partial_{\tau} G(\widetilde{x}-y, t, \tau)
$$

and by definition, we have

\mathcal{E}(\widetilde{x}-y, t) G(\widetilde{x}-y, t, \tau)=\mathcal{E}(\widetilde{x}-y, T+t-\tau)
$$

Together with Green's second formula we finally obtain

\begin{aligned}
& \left(M_{0} u(\cdot, T)\right)(\widetilde{x}, t)=\int_{0}^{T} \int_{\Omega} \mathcal{E}(\widetilde{x}-y, T+t-\tau) \Delta_{y} u(y, \tau) d y d \tau \\
& \quad-\int_{0}^{T} \int_{\Omega} u(y, \tau) \Delta_{y} \mathcal{E}(\widetilde{x}-y, T+t-\tau) d y d \tau+\int_{\Omega} \mathcal{E}(\widetilde{x}-y, T+t) u_{0}(y) d y \\
& =\int_{0}^{T} \int_{\Gamma} \mathcal{E}(\widetilde{x}-y, T+t-\tau) \frac{\partial}{\partial n_{y}} u(y, \tau) d s_{y} d \tau \\
& \quad-\int_{\Gamma} u(y, \tau) \frac{\partial}{\partial n_{y}} \mathcal{E}(\widetilde{x}-y, T+t-\tau) d s_{y} d \tau+\int_{\Omega} \mathcal{E}(\widetilde{x}-y, T+t) u_{0}(y) d y
\end{aligned}
$$

and this gives a modified representation formula for the adjoint variable for $(\widetilde{x}, t) \in Q$,

& \kappa_{T} p(\widetilde{x}, t)= \int_{0}^{t} \int_{\Gamma} \mathcal{E}(\widetilde{x}-y, t-\tau) \frac{\partial}{\partial n_{y}} \kappa_{T} p(y, \tau) d s_{y} d \tau-\int_{\Omega} \mathcal{E}(\widetilde{x}-y, t) \bar{u}(y) d y  \tag{3.6}\\

### 3.3 Mapping properties

To investigate the properties of the composed boundary integral operator $\mathcal{T}_{\alpha}$ as defined in (3.10), let us summarize some properties of the bi-layer heat boundary integral operators $V_{1}$ and $K_{1}$ which are similar to the properties of the Bi-Laplace boundary integral operators as considered in [10, 12].

\left\langle A\binom{\omega}{\varphi}, \kappa_{T}\binom{\omega}{\varphi}\right\rangle_{\Sigma}=\int_{\Omega \cup \Omega_{R}^{c}}[u(x, 0)]^{2} d x-\int_{\partial B_{R} \times I} \kappa_{T} u \partial_{r} v d s_{x} d t+\int_{\partial B_{R} \times I} \kappa_{T} v \partial_{r} u d s_{x} d t .
$$

We will show that the last two terms tend to zero as $R \rightarrow \infty$. To do this, let us consider the function $v$ first. Let us choose $0<R_{0}<R$ such that $\bar{\Omega} \subset B_{R_{0}}$. By the representation formula for the solution $v$ of the heat equation, it follows that outside $Q_{R_{0}}^{c}$, in particular for $|x|>R_{0}$, the function $v$ coincides with
$v_{0}(x, t):=\int_{0}^{t} \int_{\partial B_{R_{0}}} \mathcal{E}(x-y, t-\tau) \omega_{0}(y, \tau) d s_{y} d \tau-\int_{0}^{t} \int_{\partial B_{R_{0}}} \frac{\partial}{\partial n_{y}} \mathcal{E}(x-y, t-\tau) \varphi_{0}(y, \tau) d s_{y} d \tau$,
where the single and the double layer potentials are now defined for density functions on $\Sigma_{R_{0}}:=\partial B_{R_{0}} \times I$, i.e. $\omega_{0}:=\left.\partial_{r} v\right|_{\Sigma_{R_{0}}}, \varphi_{0}:=\left.v\right|_{\Sigma_{R_{0}}}$. The densities $\omega_{0}, \varphi_{0}$, as well as the boundary $\Sigma_{R_{0}}$, are smooth. We can now easily estimate $v$, and $\partial_{r} v$ on the boundary $\Sigma_{R}$ for $R>R_{0}$, using the behaviour of the fundamental solution $\mathcal{E}(x, t)$. From the simple estimates, for all $\mu \in \mathbb{R}$,

|\mathcal{E}(x, t)| \leq c_{\mu} t^{-\mu}|x|^{2 \mu-d}, \quad|\nabla \mathcal{E}(x, t)| \leq c_{\mu} t^{-\mu}|x|^{2 \mu-d-1}
$$

and

\left|\frac{\partial^{2}}{\partial x_{i} \partial x_{j}} \mathcal{E}(x, t)\right| \leq c_{\mu} t^{-\mu}|x|^{2 \mu-d-2}, \quad i, j=1,2,
$$

we obtain for finite $T$,

$$
\kappa_{T} v=\mathcal{O}\left(R^{-d}\right), \quad \partial_{r} v=\mathcal{O}\left(R^{-d-1}\right) \quad \text { as } \quad|x|=R \rightarrow \infty .
$$

Similarly, for $(x, t) \in \partial B_{R} \times I$, the kernel $\mathcal{E}(x-y, T+t-\tau),(y, \tau) \in \Sigma$, is smooth. Then $\kappa_{T} u$ and $\partial_{r} u$ are bounded as $|x|=R \rightarrow \infty$. Hence

-\int_{\partial B_{R} \times I} \kappa_{T} u \partial_{r} v d s_{x} d t+\int_{\partial B_{R} \times I} \kappa_{T} v \partial_{r} u d s_{x} d t=\mathcal{O}\left(R^{-1}\right) \rightarrow 0 \quad \text { as } \quad|x|=R \rightarrow \infty .
$$

Hence we finally conclude

\left\langle A\binom{\omega}{\varphi}, \kappa_{T}\binom{\omega}{\varphi}\right\rangle_{\Sigma}=\int_{\mathbb{R}^{d}}[u(x, 0)]^{2} d x \geq 0 .
$$

Corollary 3.4 The boundary integral operators $V_{1}$ and $D_{1}$ are positive semi-definite with respect to the time-twisted duality pairing $\left\langle\cdot, \kappa_{T} \cdot\right\rangle_{\Sigma}$, i.e. we have

\left\langle V_{1} \omega, \kappa_{T} \omega\right\rangle_{\Sigma} \geq 0 \quad \text { for all } \omega \in H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma), \quad\left\langle D_{1} \varphi, \kappa_{T} \varphi\right\rangle_{\Sigma} \geq 0 \quad \text { for all } \varphi \in H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)
$$

To close this section, let us recall the mapping properties of the Newton potential $M_{0}$, see [9, Lemma 7.10].

Lemma 3.5 Let $\Omega \subset \mathbb{R}^{d}$, $d=2,3$ be bounded. Then, for any $f \in L_{2}(\Omega)$ here holds

Note that, since $\mathcal{E}(x, T+t) \in C^{\infty}\left(\mathbb{R}^{d} \times \mathbb{R}_{+}\right)$for $T>0$, the operator $M_{10}$ is continuous on the considered Sobolev spaces.

We are now in a position to prove the properties of the boundary integral operator $\mathcal{T}_{\alpha}$.
Theorem 3.6 The operator $\mathcal{T}_{\alpha}: H^{\frac{1}{2}, \frac{1}{4}}(\Sigma) \rightarrow H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)$ as defined in (3.10),

is bounded, self-adjoint with respect to the inner product $\langle\cdot, \cdot\rangle_{\Sigma}$ and $H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$-elliptic, i.e. there exists a constant $c_{1}^{\mathcal{T}_{\alpha}}>0$ such that

$$

Proof. The proof is similar to the proof of Theorem 4.4 in [10], hence we skip the details. Note that, for the mapping properties of the layer heat potentials, see [3]. In particular, we have

V^{-1}: H^{\frac{1}{2}, \frac{1}{4}}(\Sigma) \rightarrow H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma), \quad K: H^{\frac{1}{2}, \frac{1}{4}}(\Sigma) \rightarrow H^{\frac{1}{2}, \frac{1}{4}}(\Sigma), \quad \widetilde{D}: H^{\frac{1}{2}, \frac{1}{4}}(\Sigma) \rightarrow H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)
$$

Since the kernels of the bi-layer heat potentials are regular, we can also derive

V_{1}: H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma) \rightarrow H^{\frac{1}{2}, \frac{1}{4}}(\Sigma), \quad K_{1}: H^{\frac{1}{2}, \frac{1}{4}}(\Sigma) \rightarrow H^{\frac{1}{2}, \frac{1}{4}}(\Sigma) .
$$

Hence we conclude the unique solvability of the variational inequality (3.9).

## 4 Symmetric boundary element approximations

In this section, we investigate a symmetric boundary integral formulation by using also a second boundary integral equation for the solution of the adjoint heat boundary value problem. We ensure unique solvability and we derive a priori error estimates for a Galerkin boundary element approximation.

In particular, when computing the normal derivative of the representation formula (3.6) of the adjoint variable $p$, this gives for all $(x, t) \in \Sigma$

where, in addition, we introduce the Newton potentials for $(x, t) \in \Sigma$
$\left(M_{1} \bar{u}\right)(x, t)=\frac{\partial}{\partial n_{x}} \int_{\Omega} \mathcal{E}(x-y, t) \bar{u}(y) d y, \quad\left(M_{11} u_{0}\right)(x, t)=\frac{\partial}{\partial n_{x}} \int_{\Omega} \mathcal{E}(x-y, T+t) u_{0}(y) d y$.
By substituting (3.2) and (3.8) into the right hand side of (4.1) we obtain the alternative representation

& -D_{1} z-M_{1} \bar{u}+M_{11} u_{0} .
\end{aligned}
$$

Hence we have to solve the variational inequality to find the control $z \in \mathcal{U}_{\mathrm{ad}}$ such that

\left\langle\mathcal{T}_{\alpha} z-g, w-z\right\rangle_{\Sigma} \geq 0 \quad \text { for all } w \in \mathcal{U}_{\mathrm{ad}} \tag{4.2}
\end{equation*}

where

\mathcal{T}_{\alpha}=\alpha \widetilde{D}+\kappa_{T} D_{1}-\kappa_{T} K_{1}^{\prime} V^{-1}\left(\frac{1}{2} I\right. & +K)-\kappa_{T}\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} K_{1}  \tag{4.3}\\
& +\kappa_{T}\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} V_{1} V^{-1}\left(\frac{1}{2} I+K\right)
\end{align*}
$$

is an alternative representation of $\mathcal{T}_{\alpha}$ as defined in (3.10), and

$$
\begin{align*}
\kappa_{T} g=\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} M_{0} \bar{u}- & M_{1} \bar{u}+\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} V_{1} V^{-1} M_{0} u_{0}  \tag{4.4}\\
& -\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} M_{10} u_{0}-K_{1}^{\prime} V^{-1} M_{0} u_{0}+M_{11} u_{0}
\end{align*}
$$

is the related right hand side.
Theorem 4.1 The operator $\mathcal{T}_{\alpha}$ as given in (4.3) coincides with the operator as defined in (3.10). In particular, $\mathcal{T}_{\alpha}$ is bounded, self-adjoint with respect to the inner product $\langle\cdot, \cdot\rangle_{\Sigma}$, and $H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$-elliptic, i.e., there holds, for some $c_{1}^{\mathcal{T}_{\alpha}}>0$,

\left\langle\mathcal{T}_{\alpha} z, z\right\rangle_{\Sigma} \geq c_{1}^{\mathcal{T}_{\alpha}}\|z\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}}^{2} \quad \text { for all } z \in H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)
$$

Proof. The self-adjointness of $\mathcal{T}_{\alpha}$ is obvious from the symmetric representation (4.3) and (3.13), (3.21), (3.22). In particular, the operators $\mathcal{T}_{\alpha}$ in the symmetric representation (4.3) and in the non-symmetric representation (3.10) coincide. Indeed, by using (3.14) and (3.16) we have

= & \alpha \widetilde{D}+\kappa_{T} D_{1}-\kappa_{T} V^{-1}\left(V K_{1}^{\prime}-K V_{1}-\frac{1}{2} V_{1}\right) V^{-1}\left(\frac{1}{2} I+K\right)-\kappa_{T}\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} K_{1} \\
= & \alpha \widetilde{D}+\kappa_{T} D_{1}-\kappa_{T} V^{-1}\left(K_{1} V-V_{1} K^{\prime}-\frac{1}{2} V_{1}\right) V^{-1}\left(\frac{1}{2} I+K\right)-\kappa_{T}\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} K_{1} \\
= & \alpha \widetilde{D}+\kappa_{T} D_{1}-\kappa_{T} V^{-1} K_{1}\left(\frac{1}{2} I+K\right)+\kappa_{T} V^{-1} V_{1}\left(\frac{1}{2} I+K^{\prime}\right) V^{-1}\left(\frac{1}{2} I+K\right) \\
& -\kappa_{T}\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} K_{1} .
\end{aligned}
$$

By using (3.15), (3.14) and (3.18) we further conclude

& \quad-\kappa_{T}\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} K_{1} \\
= & \alpha \widetilde{D}+\kappa_{T} V^{-1}\left(V D_{1}-K_{1}\left(\frac{1}{2} I+K\right)+V_{1} V^{-1}\left(\frac{1}{2} I+K\right)-V_{1} D-\left(\frac{1}{2} I+K\right) K_{1}\right) \\
= & \alpha \widetilde{D}+\kappa_{T} V^{-1}\left(V_{1} V^{-1}\left(\frac{1}{2} I+K\right)-K_{1}\right) \\
= & \alpha \widetilde{D}-\kappa_{T} V^{-1} K_{1}+\kappa_{T} V^{-1} V_{1} V^{-1}\left(\frac{1}{2} I+K\right)
\end{aligned}
$$

and we obtain the non-symmetric representation (3.10).
Moreover, the ellipticity estimate can be shown directly by using Lemma 3.3. Indeed, for $z \in H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$ and $\omega=V^{-1}\left(\frac{1}{2} I+K\right) z \in H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)$ we have

& -\left\langle\kappa_{T}\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} K_{1} z, z\right\rangle_{\Sigma}+\left\langle\kappa_{T}\left(\frac{1}{2} I+K^{\prime}\right) V^{-1} V_{1} \omega, z\right\rangle_{\Sigma} \\
= & \alpha\langle\widetilde{D} z, z\rangle_{\Sigma}+\left\langle\kappa_{T} D_{1} z, z\right\rangle_{\Sigma}-\left\langle K_{1}^{\prime} \omega, \kappa_{T} z\right\rangle_{\Sigma}-\left\langle K_{1} z, \kappa_{T} \omega\right\rangle_{\Sigma}+\left\langle V_{1} \omega, \kappa_{T} \omega\right\rangle_{\Sigma} \\
\geq & \alpha\langle\widetilde{D} z, z\rangle_{\Sigma} \geq \alpha c_{1}^{D}\|z\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}}^{2} .
\end{aligned}
$$

Hence the variational inequality (4.2) admits a unique solution. Moreover, in consequence of the alternative representation (4.4) of the right hand side $g$ as defined in (3.11), we obtain the following corollary.

Corollary 4.2 For any $u_{0}, \bar{u} \in L_{2}(\Omega)$ there hold the identities

### 4.1 Galerkin boundary element approximations

In what follows, we study the numerical solution of the variational inequality (4.2) by a Galerkin boundary element method. The ellipticity of the Schur complement boundary integral operator $\mathcal{T}_{\alpha}$ will imply the quasi-optimality of Galerkin approximations. Let us first introduce some finite dimensional trial spaces.

For the approximating subspaces of $H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)$ and $H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$ it is customary to use tensor products of spaces of functions of the space variables and of spaces of functions of the time variable. We introduce a standard class of tensor product spaces

$$
Q_{h}^{d_{x}, d_{t}}(\Sigma)=S_{h_{x}}^{d_{x}}(\Gamma) \otimes T_{h_{t}}^{d_{t}}
$$

which are based on polynomials of degree $d_{t}$ in time and polynomials of degree $d_{x}$ in space, see [3, 9]. We choose an approximation for the Neumann data $\omega, q$ which is piecewise constant both in space and in time. For continuous functions $z_{1}$ and $z_{2}$, we define the discrete convex set

\mathcal{U}_{h}:=\left\{w_{h} \in Q_{h}^{1,0}(\Sigma): z_{1}\left(x_{i}, t_{j}\right) \leq w_{h}\left(x_{i}, t_{j}\right) \leq z_{2}\left(x_{i}, t_{j}\right) \quad \text { for all nodes }\left(x_{i}, t_{j}\right) \in \Sigma\right\},
$$

where $Q_{h}^{1,0}(\Sigma)$ is a boundary element space of piecewise linear and continuous basis functions in space and piecewise constant ones in time. Then the Galerkin discretization of the variational inequality (4.2) is to find $z_{h} \in \mathcal{U}_{h}$ such that

Theorem 4.3 Let $z \in \mathcal{U}_{\text {ad }}$ and $z_{h} \in \mathcal{U}_{h}$ be the unique solutions of the variational inequalities (4.2) and (4.7), respectively. Then there holds the error estimate

when assuming $z, z_{1}, z_{2} \in H^{s, \frac{s}{2}}(\Sigma)$ and $\mathcal{T}_{\alpha} z-g \in H^{s-1, \frac{s-1}{2}}(\Sigma)$ for some $s \in\left[\frac{1}{2}, 2\right]$.
Proof. The assertion follows from standard a priori error estimates for first kind variational inequalities, see in particular the discussion in [14].
Since the composed boundary integral operator $\mathcal{T}_{\alpha}$ and the right hand side $g$ as defined in (4.3), (4.4) do not allow a practical implementation in general, instead of (4.7) we consider a perturbed variational inequality to find $\widehat{z}_{h} \in \mathcal{U}_{h}$ such that

Theorem 4.4 Let $\widehat{\mathcal{T}}_{\alpha}: H^{\frac{1}{2}, \frac{1}{4}}(\Sigma) \rightarrow H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)$ be a bounded and $Q_{h}^{1,0}(\Sigma)$-elliptic approximation of $\mathcal{T}_{\alpha}$ satisfying

\left\langle\widehat{\mathcal{T}}_{\alpha} z_{h}, z_{h}\right\rangle_{\Sigma} \geq c_{1}^{\widehat{\mathcal{T}}_{\alpha}}\left\|z_{h}\right\|_{H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)}^{2} \quad \text { for all } z_{h} \in Q_{h}^{1,0}(\Sigma)
$$

and

$$
\left\|\widehat{\mathcal{T}}_{\alpha} z\right\|_{H^{-\frac{1}{2},-\frac{1}{4}(\Sigma)}} \leq c_{2}^{\widehat{\mathcal{T}}_{\alpha}}\|z\|_{H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)} \quad \text { for all } z \in H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)
$$

Let $\widehat{g} \in H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)$ be some approximation of $g$. For the unique solution $\widehat{z}_{h} \in \mathcal{U}_{h}$ of the perturbed variational inequality (4.9) there holds the error estimate

$$
\begin{equation*}
\left\|z-\widehat{z}_{h}\right\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}} \leq c_{1}\left\|z-z_{h}\right\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}}+c_{2}\left(\left\|\left(\mathcal{T}_{\alpha}-\widehat{\mathcal{T}}_{\alpha}\right) z\right\|_{H^{-\frac{1}{2},-\frac{1}{4}(\Sigma)}}+\|g-\widehat{g}\|_{H^{-\frac{1}{2},-\frac{1}{4}(\Sigma)}}\right) \tag{4.10}
\end{equation*}
$$

where $z_{h} \in \mathcal{U}_{h}$ is the unique solution of the discrete variational inequality (4.7).
Proof. Since the operator $\widehat{\mathcal{T}}_{\alpha}$ is bounded and $Q_{h}^{1,0}(\Sigma)$-elliptic, the discrete variational inequality (4.9) admits a unique solution. From this we further obtain

& \leq\left\langle\widehat{\mathcal{T}}_{\alpha} z_{h}, z_{h}-\widehat{z}_{h}\right\rangle_{\Sigma}+\left\langle\widehat{g}, \widehat{z}_{h}-z_{h}\right\rangle_{\Sigma}+\left\langle\mathcal{T}_{\alpha} z_{h}, \widehat{z}_{h}-z_{h}\right\rangle_{\Sigma}-\left\langle g, \widehat{z}_{h}-z_{h}\right\rangle_{\Sigma} \\
& =\left\langle\widehat{\mathcal{T}}_{\alpha} z_{h}, z_{h}-\widehat{z}_{h}\right\rangle_{\Sigma}+\left\langle\widehat{g}-g, \widehat{z}_{h}-z_{h}\right\rangle_{\Sigma}+\left\langle\mathcal{T}_{\alpha} z_{h}, \widehat{z}_{h}-z_{h}\right\rangle_{\Sigma} \\
& \leq\left(\left\|\left(\widehat{\mathcal{T}}_{\alpha}-\mathcal{T}_{\alpha}\right) z_{h}\right\|_{H^{-\frac{1}{2},-\frac{1}{4}(\Sigma)}}+\|g-\widehat{g}\|_{H^{-\frac{1}{2},-\frac{1}{4}(\Sigma)}}\right)\left\|z_{h}-\widehat{z}_{h}\right\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}} .
\end{aligned}
$$

By using the triangle inequality and the boundedness of $\mathcal{T}_{\alpha}$ and $\widehat{\mathcal{T}}_{\alpha}$ we have

& \leq\left\|\left(\widehat{\mathcal{T}}_{\alpha}-\mathcal{T}_{\alpha}\right) z\right\|_{H^{-\frac{1}{2},-\frac{1}{4}}(\Sigma)}+\left(c_{2}^{\mathcal{T}_{\alpha}}+c_{2}^{\mathcal{T}_{\alpha}}\right)\left\|z-z_{h}\right\|_{H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)} .
\end{aligned}
$$

The assertion now follows from the triangle inequality

The assertion now follows by applying Cea's lemma.
By using the approximation property of the trial space $Q_{h}^{0,0}(\Sigma)$, we conclude an error estimate from (4.12) when assuming some regularity of $q_{z}$ and $\omega_{z}$, respectively.

for all $w_{h} \in \mathcal{U}_{h}$, where we introduce $q_{h}:=q_{\hat{z}_{h}, h}+\widetilde{q}_{h} \in Q_{h}^{0,0}(\Sigma)$ which is the unique solution of the Galerkin variational problem

K_{j k}^{1}[i][n] & =\left\langle K_{1}\left[\varphi_{n}^{1}(x) \psi_{k}^{0}(t)\right], \varphi_{i}^{0}(x) \kappa_{T} \psi_{j}^{0}(t)\right\rangle_{\Sigma},
\end{aligned}
$$

for $i, \ell=0,1, \ldots, N_{0}-1 ; n=0,1, \ldots, N_{1}-1$.
With these notations, the system (4.17) can be written in the form

$$
\begin{equation*}
\sum_{k=0}^{N-1}\left(V_{j k}^{1} \underline{\omega}_{k}+V_{j k} \underline{q}_{k}-K_{j k}^{1} \underline{z}_{k}\right)=\underline{f}_{j}^{1}, \quad \text { for } \quad j=0,1, \ldots, N-1 \tag{4.19}
\end{equation*}
$$

In the same way, the system (4.18) reads

$$
\begin{equation*}
\sum_{k=0}^{N-1} V_{j k} \underline{\omega}_{k}-\sum_{k=0}^{N-1}\left(\frac{1}{2} M_{j k}+K_{j k}\right) \underline{z}_{k}=\underline{f}_{j}^{2}, \quad \text { for } \quad j=0,1, \ldots, N-1 \tag{4.20}
\end{equation*}
$$

where the matrices $M_{j k}, K_{j k} \in \mathbb{R}^{N_{0} \times N_{1}}$ are defined by

$$
\begin{aligned}
M_{j k}[i][n] & =\left\langle\varphi_{n}^{1}(x) \psi_{k}^{0}(t), \varphi_{i}^{0}(x) \kappa_{T} \psi_{j}^{0}(t)\right\rangle_{\Sigma}, \\
K_{j k}[i][n] & =\left\langle K\left[\varphi_{n}^{1}(x) \psi_{k}^{0}(t)\right], \varphi_{i}^{0}(x) \kappa_{T} \psi_{j}^{0}(t)\right\rangle_{\Sigma}
\end{aligned}
$$

and

$$
f_{j}^{2}[i]=-\left\langle M_{0} u_{0}, \varphi_{i}^{0}(x) \kappa_{T} \psi_{j}^{0}(t)\right\rangle_{\Sigma} .
$$

Let us rewrite the linear systems (4.19) and (4.20) as follows. For the $N^{2}$ matrices $A_{j k}$, $j, k=0,1, \ldots, N-1$, which correspond to one of the layer heat potentials $A$, i.e.,

$$
A_{j k}[i][\ell]=\left\langle A\left[\varphi_{\ell}^{0}(x) \psi_{k}^{0}(t)\right], \varphi_{i}^{0}(x) \kappa_{T} \psi_{j}^{0}(t)\right\rangle_{\Sigma},
$$

we denote a block matrix $A_{h}$ by

$$
A_{h}:=\left(\begin{array}{cccc}
A_{00} & A_{01} & \cdots & A_{0, N-1} \\
A_{10} & A_{11} & \cdots & A_{1, N-1} \\
\vdots & \vdots & \vdots & \vdots \\
A_{N-1,0} & A_{N-1,1} & \cdots & A_{N-1, N-1}
\end{array}\right) .
$$

We define a vector $\underline{a}$ which is constructed from the $N$ vectors $\underline{a}_{k}$ by

$$
\underline{a}:=\left(\begin{array}{llll}
\underline{a}_{0}^{\top} & \underline{a}_{1}^{\top} & \cdots & \underline{a}_{N-1}^{\top}
\end{array}\right)^{\top} .
$$

With these notations, the inner product of two vectors $A_{h} \underline{a}$ and $\underline{b}$ can be expressed by the time-twisted duality, i.e.,

$$
\left(A_{h} \underline{a}, \underline{b}\right)=\left\langle A a_{h}, \kappa_{T} b_{h}\right\rangle_{\Sigma},
$$

where $a_{h}, b_{h}$ are trial functions whose coefficients of the expansions in trial spaces correspond to the vectors $\underline{a}, \underline{b}$. Here the operator $A$ can be one of the layer heat potentials $V, K, V_{1}, \ldots$ In case of the identity operator, we have a mass matrix $M_{h}$, as usual.

We now rewrite the linear systems (4.19) and (4.20) in the forms

$$
\begin{equation*}
V_{1, h} \underline{\omega}+V_{h} \underline{q}-K_{1, h} \underline{z}=\underline{f}^{1} \tag{4.21}
\end{equation*}
$$

and

$$
\begin{equation*}
V_{h} \underline{\omega}-\left(\frac{1}{2} M_{h}+K_{h}\right) \underline{z}=\underline{f}^{2}, \tag{4.22}
\end{equation*}
$$

respectively.

### 4.3 Discrete variational inequality

Analogously, we can also reformulate the perturbed variational inequality (4.16) to find $\underline{z} \in \mathbb{R}^{N_{1} N} \leftrightarrow \widehat{z}_{h} \in \mathcal{U}_{h}$ such that

$$
\begin{equation*}
\left(\alpha \widetilde{D}_{h} \underline{z}+D_{1, h} \underline{z}-K_{1, h}^{\top} \underline{\omega}-\left(\frac{1}{2} M_{h}^{\top}+K_{h}^{\top}\right) \underline{q}, \underline{w}-\underline{z}\right) \geq\left(\underline{f}^{3}, \underline{w}-\underline{z}\right) \tag{4.23}
\end{equation*}
$$

for all $\underline{w} \in \mathbb{R}^{N_{1} N} \leftrightarrow w_{h} \in \mathcal{U}_{h}$, where $\underline{\omega}, \underline{q} \in \mathbb{R}^{N_{0} N}$ are the unique solutions of the linear systems (4.22), (4.21), respectively. Here, in addition, we define the matrices $D_{j k}^{1}, \widetilde{D}_{j k} \in$
$\mathbb{R}^{N_{1} \times N_{1}}$ and the vectors $\underline{f}_{j}^{3} \in \mathbb{R}^{N_{1}}$ by

$$
\begin{aligned}
D_{j k}^{1}[m][n] & =\left\langle D_{1}\left[\varphi_{n}^{1}(x) \psi_{k}^{0}(t)\right], \varphi_{m}^{1}(x) \kappa_{T} \psi_{j}^{0}(t)\right\rangle_{\Sigma}, \\
\widetilde{D}_{j k}[m][n] & =\frac{1}{2}\left\langle D\left[\varphi_{n}^{1}(x) \psi_{k}^{0}(t)\right], \varphi_{m}^{1}(x) \psi_{j}^{0}(t)\right\rangle_{\Sigma}+\frac{1}{2}\left\langle D\left[\varphi_{n}^{1}(x) \kappa_{T} \psi_{k}^{0}(t)\right], \varphi_{m}^{1}(x) \kappa_{T} \psi_{j}^{0}(t)\right\rangle_{\Sigma}, \\
f_{j}^{3}[m] & =\left\langle M_{11} u_{0}-M_{1} \bar{u}, \varphi_{m}^{1}(x) \kappa_{T} \psi_{j}^{0}(t)\right\rangle_{\Sigma}
\end{aligned}
$$

for $j, k=0,1, \ldots, N-1 ; m, n=0,1, \ldots, N_{1}-1$. Note that

$$
\left(\widetilde{D}_{h} \underline{a}, \underline{b}\right)=\left\langle\widetilde{D} a_{h}, b_{h}\right\rangle_{\Sigma} \quad \text { for all } \underline{a}, \underline{b} \in \mathbb{R}^{N_{1} N} \leftrightarrow a_{h}, b_{h} \in Q_{h}^{1,0}(\Sigma) .
$$

The Galerkin matrix $V_{h}$ of the single layer heat potential $V$ is symmetric and positive definite, hence it is invertible, and we can determine $\underline{\omega}$ and $\underline{q}$ from (4.22) and (4.21). Then the discrete variational inequality (4.23) is equivalent to

$$
\begin{equation*}
\left(\mathcal{T}_{\alpha, h} \underline{z}, \underline{w}-\underline{z}\right) \geq(\underline{g}, \underline{w}-\underline{z}) \quad \text { for all } \underline{w} \in \mathbb{R}^{N_{1} N} \leftrightarrow w_{h} \in \mathcal{U}_{h}, \tag{4.24}
\end{equation*}
$$

where

$$
\begin{align*}
\mathcal{T}_{\alpha, h}= & \alpha \widetilde{D}_{h}+D_{1, h}-\left(\frac{1}{2} M_{h}^{\top}+K_{h}^{\top}\right) V_{h}^{-1} K_{1, h}-K_{1, h}^{\top} V_{h}^{-1}\left(\frac{1}{2} M_{h}+K_{h}\right)  \tag{4.25}\\
& +\left(\frac{1}{2} M_{h}^{\top}+K_{h}^{\top}\right) V_{h}^{-1} V_{1, h} V_{h}^{-1}\left(\frac{1}{2} M_{h}+K_{h}\right)
\end{align*}
$$

defines a symmetric Galerkin boundary element approximation of the self-adjoint operator $\mathcal{T}_{\alpha}$ and

$$
\begin{equation*}
\underline{g}=\underline{f}^{3}+K_{1, h}^{\top} V_{h}^{-1} \underline{f}^{2}+\left(\frac{1}{2} M_{h}^{\top}+K_{h}^{\top}\right) V_{h}^{-1}\left(\underline{f}^{1}-V_{1, h} V_{h}^{-1} \underline{f}^{2}\right) \tag{4.26}
\end{equation*}
$$

is the related boundary element approximation of the right hand side $g$ as defined in (4.4).
Lemma 4.7 The symmetric matrix $\mathcal{T}_{\alpha, h}$ as defined in (4.25) is positive definite, i.e.,

$$
\left(\mathcal{T}_{\alpha, h \underline{z}}, \underline{z}\right) \geq \alpha c_{1}^{D}\left\|z_{h}\right\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}}^{2} \quad \text { for all } \underline{z} \in \mathbb{R}^{N_{1} N} \leftrightarrow z_{h} \in Q_{h}^{1,0}(\Sigma) .
$$

Proof. While the symmetry of $\mathcal{T}_{\alpha, h}$ is obvious, the positive definiteness follows by using Lemma 3.3. Indeed, by using the symmetry of $V_{h}$ and with $\underline{\omega}=V_{h}^{-1}\left(\frac{1}{2} M_{h}+K_{h}\right) \underline{z}$, we have

$$
\begin{aligned}
\left(\mathcal{T}_{\alpha, h} \underline{z}, \underline{z}\right) & =\alpha\left(\widetilde{D}_{h} \underline{z}, \underline{z}\right)+\left(D_{1, h} \underline{z}, \underline{z}\right)-2\left(K_{1, h}, \underline{z}, \underline{\omega}\right)+\left(V_{1, h} \underline{\omega}, \underline{\omega}\right), \\
& =\alpha\left\langle\widetilde{D} z_{h}, z_{h}\right\rangle_{\Sigma}+\left\langle D_{1} z_{h}, \kappa_{T} z_{h}\right\rangle_{\Sigma}-2\left\langle K_{1} z_{h}, \kappa_{T} \omega_{h}\right\rangle_{\Sigma}+\left\langle V_{1} \omega_{h}, \kappa_{T} \omega_{h}\right\rangle_{\Sigma}, \\
& \geq \alpha\left\langle\widetilde{D} z_{h}, z_{h}\right\rangle_{\Sigma} \geq \alpha c_{1}^{D}\left\|z_{h}\right\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}}^{2}
\end{aligned}
$$

Hence we conclude the unique solvability of the variational inequality (4.24) and (4.9) as well. Moreover, we can derive an error estimate for the approximate control solution $\widehat{z}_{h}$ by applying Theorem 4.4 and with the error estimates (4.8), (4.13) and (4.15).

Theorem 4.8 Let $z$ and $\widehat{z}_{h}$ be the unique solutions of the variational inequalities (4.2) and (4.9), respectively. Then there holds the error estimate

$$
\begin{aligned}
& \left\|z-\widehat{z}_{h}\right\|_{H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)} \leq c_{1}\left(h_{x}^{s+\frac{1}{2}}+h_{t}^{\frac{1}{2}\left(s+\frac{1}{2}\right)}\right)\|z\|_{H^{s+1, \frac{s+1}{2}}(\Sigma)}+c_{2}\left(h_{x}^{\frac{1}{2}}+h_{t}^{\frac{1}{4}}\right)\left(h_{x}^{s}+h_{t}^{\frac{s}{2}}\right)\left\|q_{z}\right\|_{H^{s, \frac{s}{2}}(\Sigma)} \\
& \quad+c_{3}\left(h_{x}^{\frac{1}{2}}+h_{t}^{\frac{1}{4}}\right)\left(h_{x}^{s}+h_{t}^{\frac{s}{2}}\right)\left(\left\|\omega_{z}\right\|_{H^{s, \frac{s}{2}}(\Sigma)}+\left\|q_{\bar{u}, u_{0}}\right\|_{H^{s, \frac{s}{2}}(\Sigma)}+\left\|\omega_{u_{0}}\right\|_{H^{s, \frac{s}{2}}(\Sigma)}\right)
\end{aligned}
$$

when assuming $z \in H^{s+1, \frac{s+1}{2}}(\Sigma)$ and $q_{z}, \omega_{z}, q_{\bar{u}, u_{0}}, \omega_{u_{0}} \in H^{s, \frac{s}{2}}(\Sigma)$ for some $s \in[0,1]$.
In particular, if there are constants $c_{1}, c_{2}>0$ such that

$$
c_{1} h_{x}^{2} \leq h_{t} \leq c_{2} h_{x}^{2}
$$

we obtain the estimate

$$
\begin{equation*}
\left\|z-\widehat{z}_{h}\right\|_{H^{\frac{1}{2}, \frac{1}{4}(\Sigma)}} \leq c\left(z, \bar{u}, u_{0}\right) h_{x}^{s+\frac{1}{2}} \quad \text { for } z \in H^{s+1, \frac{s+1}{2}}(\Sigma), s \in[0,1] . \tag{4.27}
\end{equation*}
$$

In the case of a non-constrained minimization problem, instead of the discrete variational inequality (4.24) we have to solve the linear system

$$
\mathcal{T}_{\alpha, h} \underline{z}=\underline{g},
$$

which can be written as

$$
\left(\begin{array}{ccc}
V_{1, h} & V_{h} & -K_{1, h}  \tag{4.28}\\
V_{h} & & -\left(\frac{1}{2} M_{h}+K_{h}\right) \\
-K_{1, h}^{\top} & -\left(\frac{1}{2} M_{h}^{\top}+K_{h}^{\top}\right) & D_{1, h}+\alpha \widetilde{D}_{h}
\end{array}\right)\left(\begin{array}{l}
\underline{\omega} \\
\frac{q}{z} \\
\underline{\underline{~}}
\end{array}\right)=\left(\begin{array}{l}
\underline{f}^{1} \\
\underline{f}^{2} \\
\underline{f}^{3}
\end{array}\right) .
$$

## 5 Numerical results

As a numerical example we consider the Dirichlet boundary control problem (2.1)-(2.3) for a circular domain $\Omega=B_{0.5}(0) \subset \mathbb{R}^{2}$. For the boundary element discretization we use a uniform boundary element mesh on several levels $L$, with $N_{0}=N_{1}=2^{L+2}$ nodes; and a uniform decomposition of the interval $(0, T)$ by $N$ time steps. We use the trial space $Q_{h}^{1,0}(\Sigma)$ of piecewise linear and continuous basis functions in the space variable $x \in \Gamma$, and piecewise constant ones in the time variable $t \in(0, T)$ to approximate the Dirichlet control $z$. For the fluxes $\omega, q$, we use the trial space $Q_{h}^{0,0}(\Sigma)$ of piecewise constant basis functions both in space and in time. We set $T=0.5$ and

$$
\bar{u}(x)=\left(x_{1}^{2}+x_{2}^{2}\right) \log \left(x_{1}^{2}+x_{2}^{2}\right)+4 x_{1} x_{2}, \quad u_{0}(x)=0, \quad \alpha=0.1, \quad z_{1}=-1, \quad z_{2}=0.11 .
$$

Since the minimizer of (2.1) is not known, we use the boundary element solutions $z_{\text {ref }}, \omega_{\text {ref }}$ for $N_{0}=N_{1}=512$ and $N=512$ as reference solutions. In Table 1, we present the errors for the control $z$ and the estimated order of convergence (eoc). The errors of the flux $\omega$ in the $L_{2}(\Sigma)$ norm are also given. Since the data are smooth in this case, we expect the optimal order of convergence 1.5 for the control $z$ in the energy space $H^{\frac{1}{2}, \frac{1}{4}}(\Sigma)$ which agrees with the theoretical results, see (4.27). In addition, in Fig. 1 we present the final optimal solution $u(\cdot, T)$ with the given target function $\bar{u}$.
